#### **BBT** recruitment 2016

Health Education England has informed us that they will not be offering Broad Based Training for the 2016 recruitment round. HEKSS was not planning to recruit for 2016 so this decision will have no immediate impact on our current programme or the trainees. Our current BBT trainees will continue their programmes and develop their BBT competencies. We understand there will be a review of specialty training programmes later this year where consideration will be given to the nature and type of training needed to support the development of the NHS and the new models of working proposed in the Five Year Forward View.

The two trainee representatives on the national BBT Governance Group, Dr Anna Rose Morris and Dr Kitty Jackson have written in response to the BMJ article about the closure of recruitment to BBT. The article is available at
